### AgCertain Industries Announces Expansion in Boone, Iowa

Today AgCertain Industries, Inc. announced its Phase II expansion plans in the Boone Industrial Park located in Boone, Iowa. The large-scale expansion plans create a site in excess of 120 acres that allows for additional storage, larger logistics load offloading via an additional rail line, and increases efficiency through co-location of an onsite tank farm. This expansion creates additional processing capability and expands the impact in the marketplace.

AgCertain Industries, Inc. made its first major investment in Boone, Iowa in 2019 with the purchase of a glycerin and edible oil refinery. The production facility is located within the Boone Industrial Park and has market access by rail, and nearby highways I-35 and IA-30. Capabilities include sale and contract manufacturing services for Halal, Kosher, certified USP grade, and technical grade glycerin as well as non-GMO and organic, edible vegetable oils. AgCertain operates as a highly certified, traceability focused supplier.
